



Trustee and Administrator Non-Compliance (by Plan Type)




Minimum Education Training (MET) Non-Compliance

Small Plan **Asset Pooling** Study

The PRB analyzed investment return and fee data reported by retirement plans for fiscal years 2007 to 2016.

Modeling suggested asset pooling could have resulted in an additional 29% increase (\$32M) in total assets for small plans between 2007 and 2016.
